County Corruption Scandal Grows

As this edition was preparing to go to press, we awoke to the news that Republican Steve Brescia of Montgomery, the longest serving member of the Orange County Legislature, stepped down from his position of Chairman of that body. On September 26 the Times Herald-Record reported that Brescia submitted a two-sentence resignation letter that gave no explanation. A day later the paper reported Brescia's assertion that a controversy involving the Orange County's Sheriff's department was the cause.

Whatever the real reason, the resignation was not entirely unexpected. In March, Brescia and six other members of the county's Industrial Development Agency (IDA) board were forced from those positions as investigations revealed a culture of corruption at the agency. After a scathing report from the State Senate's Investigations Committee, led by Cornwall's James Skoufis, and another from State Comptroller Thomas DiNapoli in conjunction with the Orange County District Attorney citing "gross negligence" in oversight, calls for Brescia to resign have grown while his support has waned.

Brescia, who was first elected to the legislature in 1993 and is concurrently the elected Mayor of the Village of Montgomery, ran into problems he when he faced charges of campaign finance violations during his unsuccessful run to unseat Senator Skoufis. He is now running to keep his seat in the legislature against Democrat Frances Fox-Pizzonia.

Since the Orange County government first elected a county executive and legislature in 1970, Republicans have occupied the county executive's office with the sole exception of Mary McPhillips' term from 1990 – 1994. They have equally dominated the legislature, currently holding fifteen of the twenty-one seats. Any government dominated by any single group for a half century, or even a generation, can become careless about ethics in how it conducts its business. Matt Rettig is running to represent Orange County's 12th Legislative District which includes all of Cornwall, and parts of New Windsor and Blooming Grove. Matt vows to open county government to the light of day. What has our current legislator said about any of this? What did he know? With your support Matt can be a part of the change that will sweep away the one-party rule that has fed off of Orange County's taxpayers for too long.

Local Elections – Your Chance to Matter

Voting in New York is easier this year than ever

Make A Plan to Vote! There are THREE WAYS TO VOTE this year:

- 1 On Election Day, November 2, at your usual polling place (you should receive a yellow postcard from the Board of Elections soon confirming your registration and polling location);
- 2 During Early Voting, which this year will begin October 23 and end October 31, at any early voting location, including "COVAC" in Cornwall at 1 Clinton Street (with staggered hours for greater convenience);
- 3 By Absentee Ballot, which again this year accepts "risk of contracting or spreading a communicable disease like COVID-19" as grounds for absentee voting (https://www.elections.ny.gov/VotingAbsentee.html). And again this year, we may apply for an absentee ballot online via the "Absentee Ballot Portal": https://absenteeballot.elections.ny.gov/. But be sure the Board of Elections receives your Absentee Ballot Application by the October 18 deadline.

Check Your Registration, and register, if necessary, on or before Friday, October 8:

Cornwall Candidate Forum To be Held October 21

As Election Day approaches, the Greater Cornwall Chamber of Commerce and the Cornwall Public Library are collaborating on a Town Candidate Forum to be held on October 21st at 6:00 P.M. so that voters will have an opportunity to "meet" the two candidates for Town Supervisor, and the four candidates vying for two seats on the Town Council. It is worth noting that one of the Council candidates, a former Town Councilman and former Town Supervisor, whose petitions were thrown out by the bipartisan Orange County Board of Elections because they were altered by hand after having been signed by voters, a violation of New York State Election Law, is not on the ballot. Consequently, he has chosen to be a write-in candidate in this year's election.

Not featured in this forum are the candidates running on the ballot for County Legislature, nor are the candidates for Town Clerk and for Receiver of Taxes. According to Scott Teresi, Recording Secretary for the Chamber, the forum was limited to six candidates in order to fit into a previously created forum template and in the interests of time; it was not limited with the specific intention of excluding any candidates.

It's notable that a write in candidate who will not appear on the ballot is included in the forum. *The Cornwall Democrat* will explore that question in the next edition.
